## REQUIREMENTS FOR CONTINUATION OF MEMBERSHIP FOR PENSIONERS/RETIRED MEMBERS/NEW MEMBERS NOT ON PERSAL

1. This circular serves to inform current PEU members on Pension, Retired and those in institutions that are not on persal of the new Banking Details that they need to go and change at their banks in order to continue with PEU membership. New members who have just retired and those not on persal also need to use these banking details.

2. Below are the Banking Details to take along to your bank to change:

<b><u>NAME OF ACCOUNT</u></b>	:	PEU Burial
<b><u>BANK</u></b>	:	NEDBANK

3. All applicants should go to their banks and arrange for Debit-Orders facility to pay R100-00 affiliation into the above Banking Details. Debit-Orders should clearly reflect applicant's details for easy identification by PEU Head Office. (Use your Surname and Initials as reference).

4. Applicants who are Pensioners should ask for copy of the Debit-Order and fax to Head Office together with:

- Letter of Retired (if Retired /Pensioner)
- Copy of your last Pay-Slip, Copy of Your ID, Address and Contact Number
- Copy of the Debit-Order, the one obtained from the bank
- Proof of Employment if (Non-Persal, i.e Private School of if on Temporary Employment).
